It was a very busy week in Olympia. House of Origin Cutoff was on 2/14/18, but per the cutoff resolution does not apply to bills necessary to implement the budget or affecting state revenue. The number of bill issues under discussion continue to be worked on and now shifts to sharing and gathering input on supplemental (operating and capital) budget proposals for the 2019 fiscal year (2018-19), and especially on the revenue necessary to enact the budget.

All this is to say it gets down to the money details before the end of the regular session on March 8.

TVW's Legislative Week in Review provides an overview of key issues discussed in the House and Senate Chambers this week; as well as spotlighting some of the insights provided by Democratic and Republican Leadership. "Finding the money" is the name of the game during the next phase of legislative deliberations. This week legislative leaders and others began more public discussions about the various options.

On Thursday, 2/15, the Washington State Economic & Revenue Forecast Council met and released the state's revenue forecast for 2017-19 which indicates projected revenue of \$647 million in the current biennium (2017-19) and \$671 million for the 2019-21 biennium. The positive forecast helps in complying with the Supreme Court's mandate to accelerate funding to public schools and also allow for some property tax relief.

ESHB 2311, concerning improving access to extracurricular activities and CTSO membership fees, received a hearing on Thursday in the Senate Early Learning & K-12 Education Committee. To hear the background on the bill from its co-sponsors (Rep. Bergquist and Rep. Harris), watch minutes 11-26 in the TVW recording. Public testimony (starting at minute 59) included three individuals who testified in support of the bill's intent to support students in poverty, but expressed strong concerns about mandating a statewide fee structure without funds that would be needed to off-set the costs. OSPI estimates the statewide impact on school district budgets would be approximately \$1.1 million. We will continue to work with the committee and bill sponsor(s) to refine the execution of the bill during the interim to improve it before this becomes policy.

HOUSE BILLS

<u>House Bill 1488: Expanding higher education opportunities for certain students</u> The amendment passed: Adds an appropriation of \$500,000 from the state general fund in fiscal year 2019 to the Washington Student Achievement Council to fund the State Need Grant.

House Bill 2610: Creating the hunger-free students' bill of rights act

The amendment passed: Prohibits school personnel, district personnel, or school volunteers from costs in excess of the served to the student, the school, or district served to the student.

The amendment passed: (1) Prohibits school personnel, district personnel, and school volunteers from taking any action directed at a student under the age of 15 to collect unpaid school meal fees. (2) Removes a provision prohibiting school personnel, district personnel, and school volunteers from publicly identifying a student who cannot pay for a meal or for meals previously served to the student. (3) Specifies that communications from a school or district about amounts owed for meals previously served to a student under the age of 15 may only be directed to the student's parent or guardian.

SENATE BILLS

<u>Senate Bill 5731: Requiring acceptance of additional high school equivalency tests</u> The amendment passed: Removes the emergency clause.

Senate Bill 5917: Requiring a systemwide credit policy regarding international baccalaureate exams The amendment passed: Requires institutions to award undergraduate college credits for a minimum score of 4 on standard-level IB exams and a minimum score of E on Cambridge International exams. Requires institutions to post credit policies for IB and Cambridge International programs on their web sites.

Senate Bill 6029: Establishing a student loan bill of rights

The amendment passed: Exempts private, nonprofit educational institutions' payment plans and accounts receivable from student education loan servicers' requirements.

Senate Bill 6087: Modifying the Washington advanced college tuition payment and college savings programs

The amendment passed: (1) Requires the committee on advanced tuition payment, in consultation with the state actuary and state investment board, to establish the unit cash value price. The unit cash value price includes the number of outstanding credits purchased before July 1, 2015, and outstanding credits accrued through the July 2017 unit rebase. Provides a ninety-day window to be set by the committee for withdrawal at the unit cash value price. Modifies effective date of the act to April 15, 2018, and declares an emergency. (2) Requires the GET committee to provide notice to eligible account holders at least thirty days prior to the unit cash value price being made available.

Senate Bill 6135: Updating application requirements for the academic acceleration incentive program. The amendment passed: (1) Includes in grant priorities high schools that have not previously received AAIP grants. (2) During the 2018-19 and 2019-20 school years only, school districts may expend a portion of the district's LAP allocation to develop a Dropout Early Warning and Intervention Data System.

Senate Bill 6162: Defining dyslexia as a specific learning disability and requiring early screening for dyslexia The amendment passed: Requires schools to report data on dyslexia screenings that are conducted for use by the Office of the Superintendent of Public Instruction (OSPI) and the Dyslexia Advisory Council when developing options for the best way to implement dyslexia screenings and advising OSPI on dyslexia. Senate Bill 6223: Concerning equitable educational outcomes for foster children and youth from preschool to postsecondary education

The amendment passed: Provides that nothing in section 2 permits disclosure of confidential information protected under federal or state law and confidential information received by the work group retains its confidentiality and may not be further disseminated except as allowed under federal and state law.

Senate Bill 6241: Concerning the January 1, 2020, implementation of the school employees' benefits board program

The amendment passed: Requires the state to provide funding to districts that is at the same or greater level than what is provided for members of PEBB.

The amendment passed: Makes technical corrections related to new and existing accounts. Removes provisions requiring the state to develop funding assumptions that take into account the proportion of people that work 630 hours or more when allocating funding to school districts and to provide funding to districts that is at the same or greater level than what is provided for members of PEBB.

The amendment passed: Establishes the salary reduction accounts in the custody of the state treasurer rather than in the state treasury since these are non-appropriated accounts.

Senate Bill 6362: Modifying basic education provisions

The amendment passed: As the professional learning days are phased in the number of late start or early release of students resulting in partial days of instruction are reduced until such days are no more than seven.

The amendment passed: Removes the restriction that the supplemental contract of the district be "timebased".

The amendment passed: Striker amendment. Removes the phase in for the increased state salary allocations and instead implements the increases in 2018-19 school year instead of the 2019-20 school year. Adjusts regionalization. Creates a salary net grant program. Revises the timeline and criteria for rebasing salaries.

The amendment passed: Corrects technical errors and provides clarifying language. 1. Clarifies which type of district is being referred to in order to prevent confusion (either high or nonhigh). 2. Adds additional clarifying language to ensure that the enrichment definition reflects the same definition as in other parts of the code. 3. Changes the percentage to reflect what running start funding for CTE students currently is.

Senate Bill 6486: Expanding registered apprenticeship programs

The amendment passed: Specifies that the coordinator at the Department of Labor and Industries should direct private sector outreach to employers and employee organizations within the technology, agriculture, aerospace and outdoor recreation manufacturing industries.

Last day to consider (pass) opposite house bills (5 p.m.) (except initiatives and alternatives to initiatives, budgets and matters necessary to implement budgets, differences between the houses, and matters incident to the interim and closing of the session).
Last day allowed for regular session under state constitution.
