Career and Technical Education (CTE) this week in Olympia:

As we approach the technical "half-way point" in the regular legislative session, which means by March 8, all bills need to be passed out of their house of origin and moved to the other chamber to continue the process.

Does that mean if a bill does not move to the other chamber, we can never assume the intent and/or content of a bill will not find another vehicle to proceed through the process? Also, remember if there is a policy that is necessary to implement the budget (NTIB) it can show up in an existing bill or a whole new bill may appear in the 11th hour of the session.

This means our work at this point is to continue advancing our approach to fund CTE in <u>SB 5183</u> within the prototypical funding model bills that address the total funding of K-12 education. If the proposed "Student Weighted" funding model as proposed by the Senate MCC in <u>SB 5607</u> comes to pass, our focus will be to understand the change for CTE and to determine how the funding will be operationalized for CTE.

Our rubric for success will be if whatever funding formula is ultimately passed this year will revolve around these key points:

- Are there additional resources for CTE program delivery going forward?
- Assurances that those resources are more directed to CTE programs
 - i.e., relieving CTE of the burden of base salaries negotiated beyond the state allocation

CTE Resources & K-12 Funding:

All of the funding bills that are currently in the works, with more to come, have some acknowledgement of CTE funding that increases funding in some way, shape, or form. The Senate passed a bill (<u>SB 5607</u>), that adds \$500 per pupil as "categorical" funding. As a per-pupil model, this is \$500 per 7-12 student in the local district, not calculated as a FTE based on student minutes, so every student generates the funding.

The current House bill (<u>HB 1843</u>) funding education uses the prototypical formula and modifies the CTE and skill center-staffing ratio to provide additional funding with increases rolled out over the next two biennial budgets.

Our original CTE funding bill (SB 5183) is technically still in the mix, which increases MSOC for CTE and skill centers, reduces indirects, and creates guidance for allowable expenditures. This approach is still in the mix and driving the conversation about CTE funding within the other funding bills.

There is a "hybrid"-funding funding bill (<u>SB 5825</u>) that assures a total per-pupil amount and then breaks it out by way of the prototypical formula. This bill uses the staffing ratio changes in <u>HB 1843</u> in the first biennial budget.

Support for CTE in Policy Bills:

We continue to pursue solutions to increase access to CTE for all students as they strive to obtain their needed credits and additional graduation requirements. Two bills that directly address the major limiting factors of required testing linked graduation and the number of credits a student is required to earn. HB 1046 is in Rules, that delinks the state testing from graduation and HB 1509 caps the required credits needed for graduation at 21 with the opportunity for 24. There is a great deal of conversation around both "concepts", don't be surprised if something along the lines of these two bills continues to progress through the process.

Federal Level Activities: (Perkins)

The ACTE National Policy Seminar is happening March 13-15, 2017, in Washington D.C., and 18 CTE educators will be attending from Washington State meeting with our congressional delegation and lending our support for Perkins reauthorization and funding. There is a strong chance they will move this bill/act in this congress.
