




Washington Tribes Map

Grants: FP 356 Health Care Simulation Grants

As a result of the 2022 Legislative Session, \$3,600,000 of the workforce education investment account— state appropriation is provided solely for the Office of the Superintendent of Public Instruction to administer grants to skill centers for nursing programs to purchase or upgrade simulation laboratory equipment.

The grant is for one time funding allocation to skill centers with approved Nursing Certified Assistant Programs to purchase or upgrade healthcare simulation equipment.

Funds may be used for:

- Training and/or professional learning when training is required to operate the new or upgraded equipment.
- Manikins, interactive videos, skill-specific anatomical models or "task trainer," computerized manikins or "patient simulators," and/or desktop virtual reality training applications.
- May include software purchases and site licenses.

Funds may not be used for general training, certification, or professional development.
