A. Region V / ACTE

Shani reported that the Region V conference is sold out at nearly 500 registrants. There are 60+ presentations scheduled. The 2025 conference will be the 50th anniversary and be held May 1-3 in Las Vegas. She also reported on the upcoming National Policy Seminar to be held March 17-20 and strongly recommended all to attend.

Karmen reported on the upcoming state officer training and the CTSO Legislative Day where all eight CTSOs interact with legislators every year. Students will talk about the importance of CTE, ask for support, tell stories, and speak about what is important to them. Focus is on HB 1915 and HB 2236. State conferences also coming up soon.

B. Legislative 2024 Legislative Focus

Tim reported on the funding formula and that the prototypical funding model needs adjustment. He reported on HB 2236 and the proposed substitute. Next step is appropriations. Problem will be when it goes to the Senate. AWB and AGC oppose bill. Reach out to Senate Early Learning & K-12 Education committee members to educate legislators what the bill will do if it passes.

C. Professional Development - Summer Conference 2024

Summer Conference will focus on AI with main speaker Rachael Mann. OSPI DEI and Tribal training. Sunday extended sessions. Call for presentations is open and due May 17. Monday OSPI sessions. Opening session at convention center opens up more space for exhibits. Registrants can attend in-person and remote if they have to come late or leave early to still earn all of their clock hours. WAAE requested sessions separate from OSPI. Professional Development reps need to work with OSPI program supervisors.

Board Discussion

A. Bylaws Proposal - New and Related Section

Tim reviewed the proposed amendments including adding back a New and Related Services Section, which will include several subgroups that represent individuals from emerging areas of Career and Technical Education unrelated to an established WA-ACTE Section or individuals from areas that provide specialized support to broad areas of CTE that often cut across all Sections. Proposed changes introduced January 27, will take a second look at on March 23, and finalized on May 18. Sections were asked to take back to their boards and bring back feedback to March meeting.
