Week one of session is in the books and started at a whirlwind pace. Just since last Friday there have been approximately 700 bills “dropped” into the process hoping to make it into law at the end of the session. With many new members these bills line up with what they are hoping to achieve while they are here.

Each week I try and give you a snippet of what is happening related to activities related to our Legislative Focus, which we use as our legislative strategic plan. From the Focus we identified two specific items to direct our actions on CTE’s behalf, this is our Legislative Action Plan (LAP). Jesse and I created, with the help of our Legislative Committee, a policy draft and are now working on having a member request the Code Revisers office to create bill language we can then work to get a sponsor and others to co-sponsor. All of this is the background work it takes to “drop” a bill into the session. We hope to drop a bill by the end of the week if all goes well. Stay tuned, once we have a bill number we will then ask for your help in moving it forward through the process.

While we are actively working on our two proposed solutions to support CTE, there are many other things happening in and around K-12 Education. The primary initiative to affect CTE at this point is the Governor’s Career Connect Washington Plan (CCW). The two companion bills to implement CCW are set to be heard Tuesday (today) in the College & Workforce Development [HB 1336](#) and Senate Higher Education & Workforce Development [SB 5327](#) committees. See the CCW Taskforce’s [policy memo](#) on the Career Connect Washington website and Governor’s [budget proposal](#), for more details on each of these proposals.

SESSION CUTOFF CALENDAR

January 14, 2019	First Day of Session
February 22, 2019	Last day to read in committee reports (pass bills out of committee and read them into the record on the floor) in house of origin, except House fiscal committees and Senate Ways & Means and Transportation committees.
March 1, 2019	Last day to read in committee reports (pass bills out of committee and read them into the record on the floor) from House fiscal committees and Senate Ways & Means and Transportation committees in house of origin.
March 13, 2019	Last day to consider (pass) bills in house of origin (5 p.m.).
April 3, 2019	Last day to read in committee reports (pass bills out of committee and read them into the record on the floor) from opposite house, except House fiscal committees and Senate Ways & Means and Transportation committees.
April 9, 2019	Last day to read in opposite house committee reports (pass bills out of committee and read them into the record on the floor) from House fiscal committees and Senate Ways & Means and Transportation committees.
April 17, 2019*	Last day to consider (pass) opposite house bills (5 p.m.) (except initiatives and alternatives to initiatives, budgets and matters necessary to implement budgets, differences between the houses, and matters incident to the interim and closing of the session).
April 28, 2019	Last day allowed for regular session under state constitution.
* After the 54th day, only initiatives, alternatives to initiatives, budgets and matters necessary to implement budgets, matters that affect state revenue, messages pertaining to amendments, differences between the houses, and matters incident to the interim and closing of the session may be considered.
