

ARTICLES OF INCORPORATION

OF

INCORPORATED IN THE STATE OF WASHINGTON

WASHINGTON VOCATIONAL ASSOCIATION

WE, the undersigned persons, acting as the incorporators of a corporation under the provisions of the Washington Nonprofit Corporation Act (R.C.W. 24.03) adopt the following articles of incorporation for such corporation:

I.

The name of the corporation shall be the Washington Vocational Association.

II.

The period of duration of the corporation shall be perpetual.

III.

The purposes for which the corporation is organized is to promote and improve the cause of Vocational Education in the State of Washington and to render service to its members, as well as to provide educational workshops, conferences and other related activities to improve education; and, further, to provide a unified organization promulgating the growth and development of Vocational Education on a statewide and national basis.

IV.

The membership of the Washington Vocational Association shall be comprised of members, associate members and student members.

a. Members. Any person engaged in Vocational Education work of a professional nature and/or who holds a regular vocational certificate shall be eligible for membership.

This shall include instructors, coordinators, supervisors, directors and other administrators employed by vocational educational agencies engaged in one or more of the several services of Vocational Education. Members are eligible to vote, to hold office in the state association or in any sectional or local unit and to serve on committees.

b. Associate Members. Any person, organization or firm not qualified as a member but interested in the promotion of Vocational Education shall be eligible for associate membership. They shall be eligible to serve on committees but shall not be entitled to vote or hold office.

c. Student Members. Any person who is a student preparing for a professional Vocational Education career shall be eligible for student membership. They shall be eligible to serve on committees but shall not be entitled to vote or hold office.

d. Retired Members. Any person who had previous membership in WVA and is retired from the teaching profession.

The membership year and the fiscal year shall be consistent and coincident, September 1, to August 31, inclusive.

V.

The address of the initial registered office of the corporation shall be Rt. 2, Box 56 J, 98310 Cheney, WA. The name of the initial registered agent of the corporation at such address shall be John W. Elliot.

VI.

The number of directors constituting the initial board of directors shall be 14 directors. At no time shall the number of directors exceed 20, nor be less than 8. The names and addresses of the persons who are to serve as the initial directors of the corporation are as follows:
