Legislative Priorities

OSPI's 2023 legislative priorities include:

- Meaningful funding and supports that center the needs of students
 - Fully fund special education
 - Student Transportation
 - Universal school meals
- Access to a diverse, inclusive, and highly skilled workforce
 - Support stable, effective school leadership
 - Expand teacher residency programs
 - Deepen investments in Beginning Educator Supports
 - Make progress in recruiting and retaining a multicultural and multilingual educator workforce—pending recommendations from the <u>K-12 Basic Education</u> <u>Compensation Advisory Committee</u>
- Equitable Access to Strong Foundations
 - o Strengthen and expand statewide dual language learning
 - \circ $\;$ Support statewide access to high-quality, hands-on science learning
- Rigorous, learner-centered options for all students
 - o Expand statewide access to Holocaust education resources
 - Expand access to dual credit opportunities for all students
 - Expand pre-apprenticeship opportunities for high school students and young adult learners to gain valuable, hands-on training in the building and construction trades.

Agency policy requests include further align high school credit requirements with student goals and interests, strengthening the High School and Beyond Plan (HSBP), and increase limit for economy and efficiency waivers under <u>RCW 28A.150.222</u> – School Days per Year Waiver.

Updates from Special Education Division

Recovery Services

In 2021, OSPI Special Education released <u>Washington's Roadmap for Special Education</u> <u>Recovery Services: 2021 & Beyond</u> and can provide ongoing guidance and technical assistance to districts, schools and families on recovery services. Recovery services are additional services to address lack of appropriate progress on IEP goals due or the IEP Transition Plan due to missed or limited services or for other reasons because of the pandemic. Recovery services decisions should have been made and documented for all students with Individualized Education Programs (IEPs) by their annual IEP meeting during the 2021-22 school year. IEP teams may decide, depending on student need, that recovery services may continue to be provided for multiple years to support students to return to expected level of progress. Students who turned age 21 during the pandemic (2019–20 or 2020–21 school years) may also need transition recovery services to return to expected levels progress towards their postsecondary goals (as indicated in the IEP Transition Plan and High School and Beyond Plan).

- The <u>Transition Recovery Service Funding for Students with Disabilities who are 21</u> <u>Questions and Answers</u> was updated in 2022 to provide clarity on transition recovery services and funding.

2021–22 American Recovery Plan (ARP) Special Education Funds Still Available! ARP funds were provided to districts to prevent, prepare, and respond to the pandemic. These supplemental special education funds are for the excess costs of providing special education and related services to students with disabilities and can include supports for students with disabilities to access and benefit from CTE programming.

When planning for the use of ARP funds, consider the following types of allowable activities:

- CTE materials, supplies, and supplemental curriculum for use with students with disabilities to mitigate gaps/challenges related to the pandemic, including the provision of recovery services.
- Professional development for special education and general education personnel who support students with disabilities in CTE.
- 1. Materials to support returning to school and accessing CTE content, such as purchasing supplies for cleaning and disinfecting classrooms.
- Specialized equipment or devices to assist students with disabilities to participate in CTE activities.

2021-22 Washington state ARP special education allocations totaled \$53,703,790. As of July 1, 2022, school districts had expended \$16,342,515 (30.4% of the total allocation). **Any unspent funds as of August 31, 2023, will go away.** <u>Click here to download the 2022-23 FP 149</u> <u>allocation listing for all LEAs</u>. NEW Special Education and CTE Training

In June 2022, the <u>Center for Change in Transition Services (CCTS)</u> launched a new self-paced training course, <u>Partnerships for Inclusion: Special Education and Career Technical Education</u>.

It features interviews with Washington state educators who share their stories and strategies for increasing inclusionary practices in their schools and districts, by emphasizing collaborations between Special Education and CTE. The five-module course is available free of charge.

Work Integrated Learning Advisory Committee (WILAC)

The ONE CTE Tribal Engagement Specialist had the opportunity to present to the WILAC committee twice this year. The first presentation was an opportunity to introduce and present current Washington state tribal programs that have been successfully implementing work and career programs in their communities. These programs included the Confederated Tribes of the Colville Reservation and Spokane Tribal Summer Youth Employment Programs, Tulalip Tribal Skills Center, the Kalispel Career Training Center and introducing Tribal Employment Rights Office (TERO) programs throughout Washington State tribes. Within this presentation,



there was an opportunity to also share the economic impacts that Washington State Tribes contribute to their local county and the state economic growth and sustainability.

The second presentation to WILAC included the partnership with Career Connect Washington and the current goals and objectives of developing and implementing culturally relevant programs to tribal students and communities throughout Washington state. There is a strong focus on data, professional development, and the continued relationship and partner building with Washington State Tribes.

Washington State Indian Education Association

The Office of Native Education in collaboration with OSPI's CTE Department presented for the first time last April at the 37th Annual Washington State Indian Education Association Conference "Revitalizing Community Connections for Native Education." Human connection is key in developing culturally relevant CTE pathways and programs and we continuously thrive to build stronger bridges to connect our communities.

Life Cycle of the Salmon

ONE has partnered with College Spark and Redd Zone in providing our school districts that serve American Indian/Alaskan Native students an opportunity to engage in our "Life Cycle of the Salmon Project." With a focus on providing this project within our STEC schools, the goal is to create a culturally relevant learning environment for our students to thrive in. The Life Cycle of the Salmon is designed to include teachers, elders and families, local tribal leaders, tribal fisheries departments, and community. Our list of current participating schools includes Cape Flattery School, Chief Kitsap Academy, Chief Leschi School, Lummi Nation School, Muckleshoot Tribal School, Pascal Sherman Indian School, Quileute Tribal School, and Toppenish School District.

Professional Development

The Office of Native Education continues to provide professional development opportunities with our collaborating partners to ensure student, family and community success. ONE provides workshops and trainings on the following topics: Sovereignty 101, Intergenerational Trauma and the Impacts on Students in Education Today, Tribal Consultation, Tribal Relations (family, student, and community engagement), and of course our Since Time Immemorial Trainings. Program and Pathway Support

Agricultural Education

- Cotton Booker from Colfax was named a finalist for the 2022 FFA American Star in Agribusiness award. He will compete against other finalists in an interview process at the National FFA Convention in October.
- The National Association of Agricultural Educators (NAAE) Board of Directors announced the names of the 2022 award winners who will be representing Region 1 at the 2022 NAAE Convention:

 - Teacher Turn the Key Melissa Rauch-Allen
- Washington Association of Agricultural Educators (WAAE) is working on re-vamping their STAR program (recruitment and retention) to include individuals from all areas of Team Ag Ed in Washington.

Business and Marketing Education

- Amazon Web Services (AWS): OSPI in collaboration with Amazon Web Services (AWS) Academy, is providing access to foundation level cloud-computing skills in public high schools and post-secondary institutions across the state. Washington educators now have the opportunity to implement AWS Academy and integrate cloud-computing education into their classrooms in Network and computer systems.
- Washington was in the top 8 for most successful states in FBLA competition. The competitive event changes for the next year have been announced with lots of good things happening <u>https://www.fbla-pbl.org/divisions/fbla/fbla-competitive-events/</u>.
 FBLA Adviser Conferences are scheduled for September 27, 2022 (Olympia area), September 28, 2022 (Wenatchee), and September 29, 2022 (Spokane).
- Congratulations to the 2022 ICDC delegation who were deemed the top competitors in the world! Washington had 77 top 10 teams; 12 first place winners; 6 second place winners; and 12 third place winners at competition in Atlanta. DECA leadership has a new 2022-2023 Advisor Guide and a Middle School Toolkit rolling out this year.



Health Sciences

- HOSA welcomes <u>Elizabeth Carnesi</u> as the new Washington State Executive Director. She comes to us from the state of Arizona where she worked as State Advisor and State Officer Coach. Prior to this she was National HOSA president.
- The Long-Term Care Nursing Proviso Curriculum workgroup developed a common curriculum framework to be used to support students meeting the requirements to become a Certified Nursing Assistant. Orientation and access is being provided the last week in July and weekly through August
- DOH began rule making changes for the Medical Assistant WAC. This may allow a candidate who is scheduled to graduate from an accredited high school to take the certification exam and receive a Provisional Certification up to twelve months before graduation as long as all certification eligibility requirements are met. The "Provisional Certification" is a placeholder and is intended to allow candidates to take the certification exams as near to the time they complete their training event though they have not yet met the eligibility criteria of holding a high school diploma. Draft language for revisions to WAC 246-827 includes reference to OSPI-approved programs as an additional pathway to fulfill training requirements. The OSPI approved program would be the completion of the two-year framework. This will assure that students meet the requirements for certification.
- DSHS and OSPI continue to partner with the Tribes and their schools in implementing a Home Care Aide program.

Family and Consumer Sciences

- FCCLA is pleased to welcome <u>Mackenzie White</u> as the new FCCLA State Officer Coach. She is a past FCCLA State President from Missouri, a past FCCLA national STAR Events participant, and has been leading a state officer team for over a year. She brings incredible FCCLA enthusiasm, Executive Council coordination experience, and a passion for student leadership.
- Washington FCCLA brought home thirty-three gold, thirty-seven silver, and nine bronze medals. There were eighty-three competitors this year at the National Leadership conference.
- Teaching Academy has a new contact at the Professional Eductor Standards Board (PESB), <u>Fernanda Diaz</u>, stepped into her role in July. There are plans to continue professional development and PLC meetings for the school year.

Skilled and Technical Sciences (STS)

- SkillsUSA welcomes Karmen Warner as new Washington Executive Director.
- SkillsUSA Washington qualified teams were able to attend national championships in Atlanta this past June. National medalist counts from Washington included two Gold, two Silver, and two Bronze.
- The Washington Association for Skilled and Technical Sciences (WASTS) and the Washington Industrial Technology Education Association (WITEA) are professionally



merging, effective the 2022-23 school year. This provides the STS and STEM program areas with one strong, universal professional organization that caters to the needs of our ever-evolving technical educational needs.

STEM

- Washington Technology Student Association (TSA) had excellent outcomes at National Conference including 55 individuals/teams on stage for Top 10 placing in competitive events. They brought home three National championships, with many 2nd and 3rd place trophies. Washington TSA has the fifth largest state membership in the country!
- State applications for 2022-23 grants in STEM education will continue to be filed through the iGrants management system. FIRST Robotics form packages (424,605 and 606) for STEM-aligned student activities, as well as Lighthouse FP545, STEM Professional Development FP658, and Advanced PLTW FP669.
- Congratulations to last year's STEM Lighthouse awardees:
 - Thorp (Thorp School District)
 - Industrial Design and Arts (Tacoma School District)
 - Evergreen Elementary (Peninsula School District)

The grant seeks to promote the work schools are doing which "identify, apply and integrate concepts from science, technology, engineering, and mathematics to understand complex problems and to innovate to solve them."

Core Plus

- Core Plus is rolling out new partnership levels for all Core Plus programs to receive supports based on levels of alignment to industry. Core Plus leadership will be providing a series of information sessions to highlight the program.
- The Core Plus Teacher Professional Development Series for both veteran and new Core Plus teachers will continue this year. Additional professional development opportunities will be offered at the annual WITEA conference this spring.
- Aerospace/Advanced Manufacturing, Construction and Maritime curriculum and support materials continue to be updated on the Moodle site. Time to log back in and check it out! For access, email <u>Roger A. Rich, Jr.</u>
- Core Plus program grant form packages (668, 919 and 920) for interested or continuing Core plus schools have launched. These grant packages will close October 3, 2022.

Industry-Recognized Certifications (IRCs)

The 2022-23 state-approved Industry Recognized Credentials list has been updated in support of school districts' efforts to adopt IRCs in accordance with the requirements of Perkins V Program Quality Measures and state program standards for the implementation of high-quality CTE programming. We anticipate the CEDARS valid values list associated with reporting elements D17 – Industry Recognized Certifications Offered, E15 – Industry Recognized Certifications Earned, and H31 – Industry Recognized Certifications Earned, to



be updated for district use in 2022-23 reporting by the fall. The updated list will be reflected in subsequent versions of the Comprehensive Education Data and Research System (CEDARS) Data Manual.

OSPI will continue to update the state-approved list to include consideration of emerging and declining occupations and related certifications with stakeholders on an annual basis to ensure the certifications are:

- Attainable by high school students and transfers seamlessly to workforce entry;
- Recognized, endorsed or issued through a national or international business, industry, professional organization; state agency, government entity or state-based industry association; and
- Valued by employers with demonstration of the skills and abilities established by industry and accepted as a validated credential for workplace entry or advancement.

Graduation and Pathway Preparation

CTE Equivalency

- New statewide equivalencies were approved by Superintendent Reykdal in March 2022, including Core Plus Aerospace (Sheet Metal Technology), Dental Assisting, updated Principles of Biomedical Science (new curriculum), Family Health and Fire Science and Emergency Services. With these new course frameworks, school districts can now select from a menu of 55 <u>CTE Statewide Course Equivalencies</u>. Each framework is the result of collaboration between committed industry partners, expert educators, and content leads resulting in best practices for delivering equivalent course work.
- We continue to expand the CTE equivalency workgroups and appreciate the commitment
 of those who volunteer for this important work. Equivalencies will be reviewed and
 evaluated in January for Computer Aided Drafting (CAD)/Advanced CAD, Business
 Communications, Textiles, Floral and Sports Medicine. Requests for additional CTE
 Statewide Course Equivalencies may be submitted using the CTE Course Equivalencies
 Frameworks Request Form found on the <u>CTE Resources webpage</u>.
- Statewide course equivalencies are developed annually with an expected approval review in January when the Statewide Course Equivalency list will be updated and ready for use by school districts. With this timeline, school administrators and counselors can incorporate state equivalencies into their master schedule and be prepared to help align/advise students with their High School and Beyond Plan for the following school year.
- CTE equivalency implementation professional development is currently in the planning process. Stay tuned for more information.



Career Connected Learning

2021-22 Career Connected Learning Highlights

Through the efforts of the many organizations supporting Career Connect WA (CCW) statewide, the nine Career Connected Learning (CCL) Coordinators each individually supporting one of Washington's ESDs with this initiative, and our K-12 CTE partners, Washington continues to make progress toward statewide outcome goals for high quality academic and career connected learning experiences:

- Eleven K-12 programs were approved for the Career Launch Endorsement. Four of the nine ESDs gained additional Career Launch Endorsed Programs. ESD 114 has two new Career Launch programs ready to be submitted for approval. There are 10 Career Launch endorsed programs ready to be implemented during the 2022 -2023 school year.
- The Northwest Rural CTE Network, originally launched as a partnership between ESDs 114 and 189, was expanded to provide statewide professional learning opportunities.
- ESD 112 implemented 13 new "flipped internships" which each address a different industry including IT, healthcare, and manufacturing, increasing the total number to 18 performance-based learning programs. The programs are designed to be adapted to any district. ESD 123 Pasco has plans to implement in the fall.
- Communication about CCL continues to expand! Originally launching in ESD 114, ESDs 121, 171 and 189 began distributing one-page news briefs and monthly or quarterly newsletters to a wide range of recipients. Topics included professional development opportunities, highlights from the region, and introductions to programs soon to be endorsed. ESD 105 also distributes their Menu of Opportunities with new Business and Industry contacts linking education and business in their region.
- Progress was made toward more equitable access to dual credit through meetings with CTE Directors and community college instructional deans.
- Student participation in paid work experiences grew from fewer than 5 in 2021 to 28 secondary students in 2022.
- Multiple, highly successful community outreach sessions on Career Launch, Career Prep, and Career Explore programs, industry convenings, and educator support programs were held throughout the year and throughout the state in response to the needs of many districts, schools, and the public. ESD 171 hosted community outreach programs such as the 8th annual College and Career Expo for students across North Central Washington, featuring sessions on resume writing and apprenticeships, financial aid, and entrepreneurship.

2022-23 Career Launch Data Update

OSPI is also working to increase understanding of how to assign the proper coding within student information systems so that Career Launch endorsed program enrollment can be accurately and easily accessed for the annual assessment of progress made through this initiative. Updates from Professional Educators Standards Board (PESB)

CTE Administrator Preparation Program Update

Organizations wishing to offer an educator preparation program in Washington must be approved by the Professional Educator Standards Board (PESB). The approval process to offer a preparation program is a three stage process. <u>Learn more on the PESB website</u>.

Two programs are currently approved by PESB to offer an Initial CTE Administrator preparation program:

1. <u>City University</u>

2. Eastern Washington University

WA-ACTE is currently in the approval process, and CWU previously submitted a Notification of Intent to begin the approval process.

Since Time Immemorial in CTE

All teacher preparation programs, including CTE preparation programs, must integrate the Since Time Immemorial (STI) curriculum into their programs and courses, and ensure that teacher candidates engage and familiarize themselves with the content. Find out more on <u>PESB's STI webpage</u>.

Social Emotional Learning in CTE

In order to ensure candidates can recognize signs of emotional or behavioral distress in students and appropriately refer students for assistance and support, all teacher and principal preparation programs, including CTE preparation programs, are require to provide guidance to candidates, which must include Social Emotional Learning and related competencies. Cultural competency, diversity, equity, and inclusion standards

Through ESSB 5044, a bill passed by the Legislature in April 2021, PESB was tasked with reviewing and revising the state's 2009 standards to ensure every educator in our state is prepared, trained, and equipped with the knowledge, skills, and tools necessary to create stronger, more supportive student-centered learning environments.



On Friday, March 25, members of the Professional Educator Standards Board unanimously approved to adopt the newest set of cultural competency, diversity, equity, and inclusion (CCDEI) standards for Washington educators.

The revised standards apply to all educator roles and will be used in the preparation of educator candidates and in professional learning opportunities throughout an educator's career. Preparation programs and professional learning providers may begin using the standards immediately. <u>View the new standards</u>.

In the coming months, PESB will produce additional outreach, resources, and information to support preparation programs and professional learning providers in implementing the new standards.
