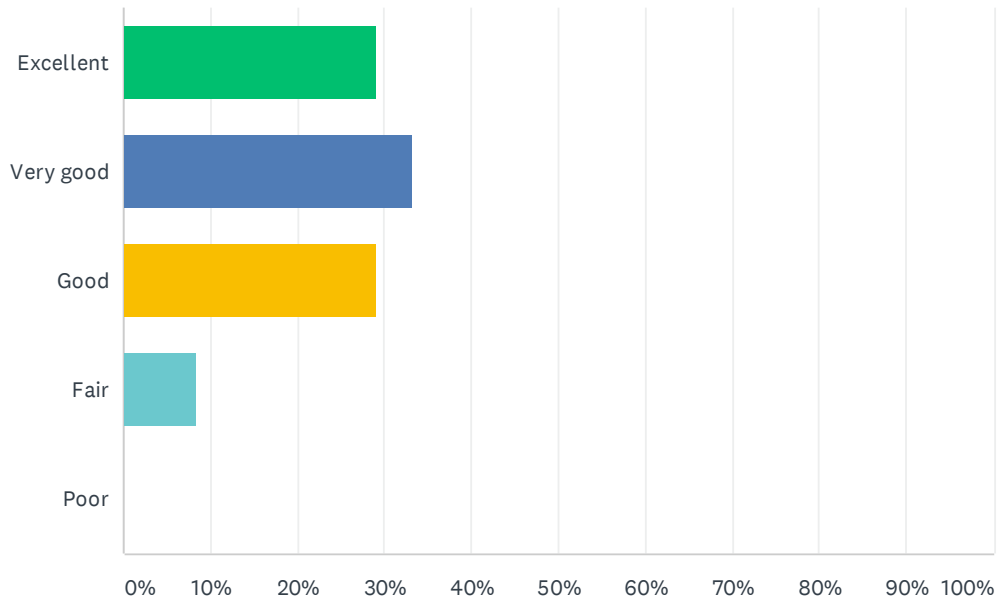


Q1 Overall, how would you rate this conference?

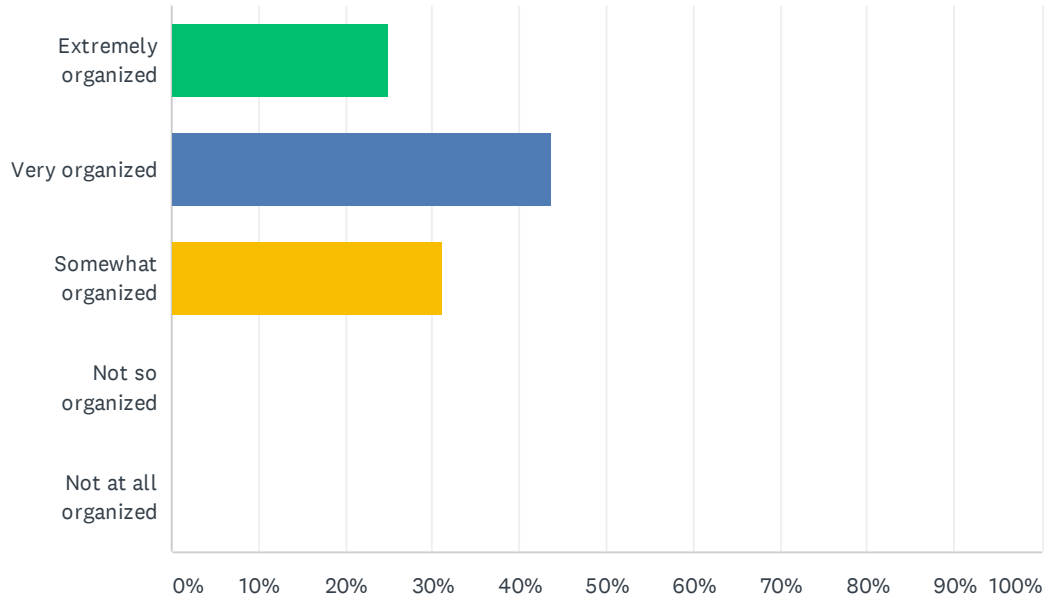

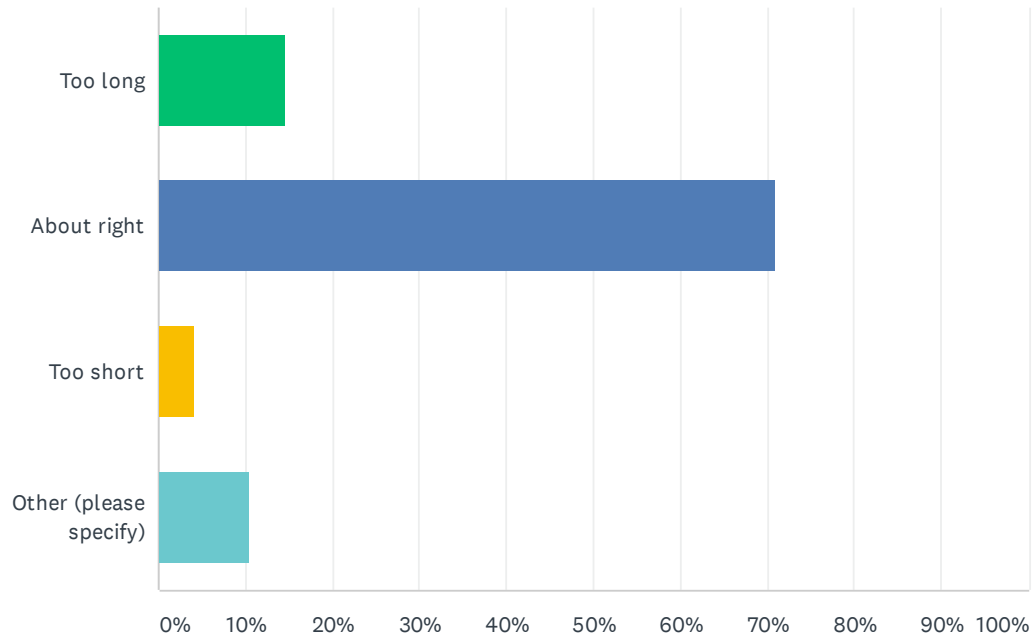

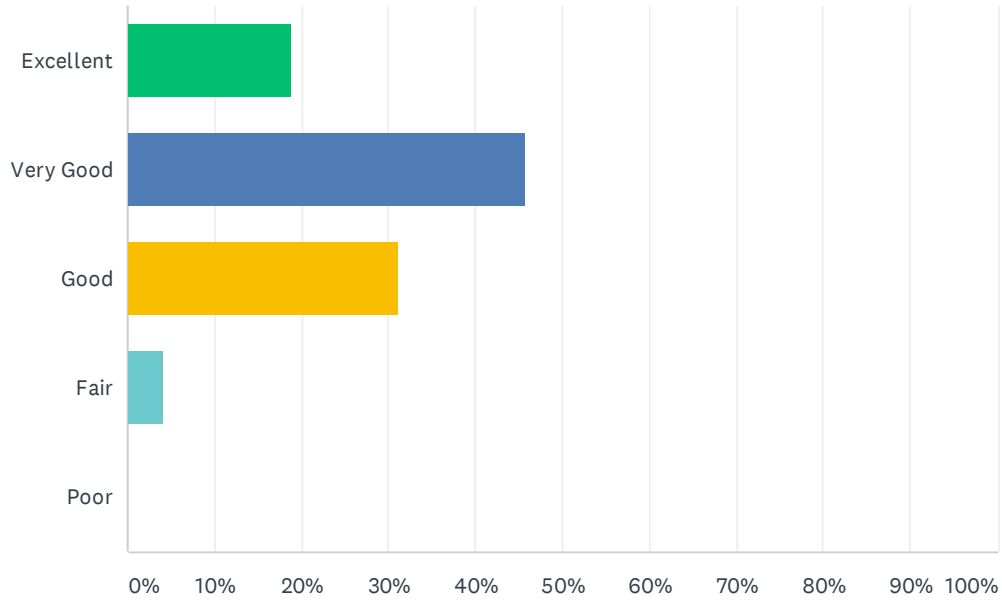

Q5 The extent to which the written objectives have been met.

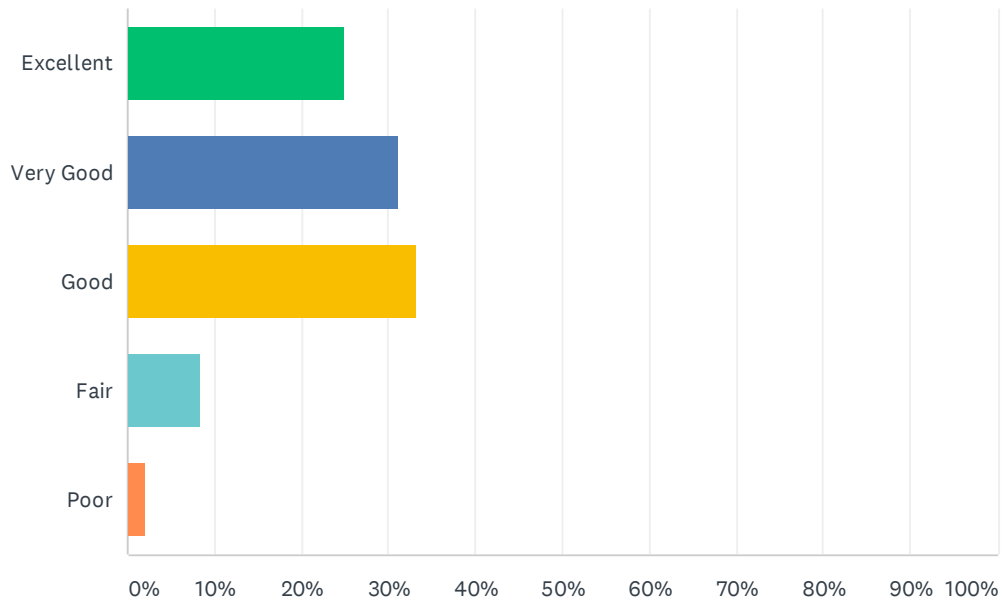

Q6 Participant perception of relevance and quality of the inservice offering.

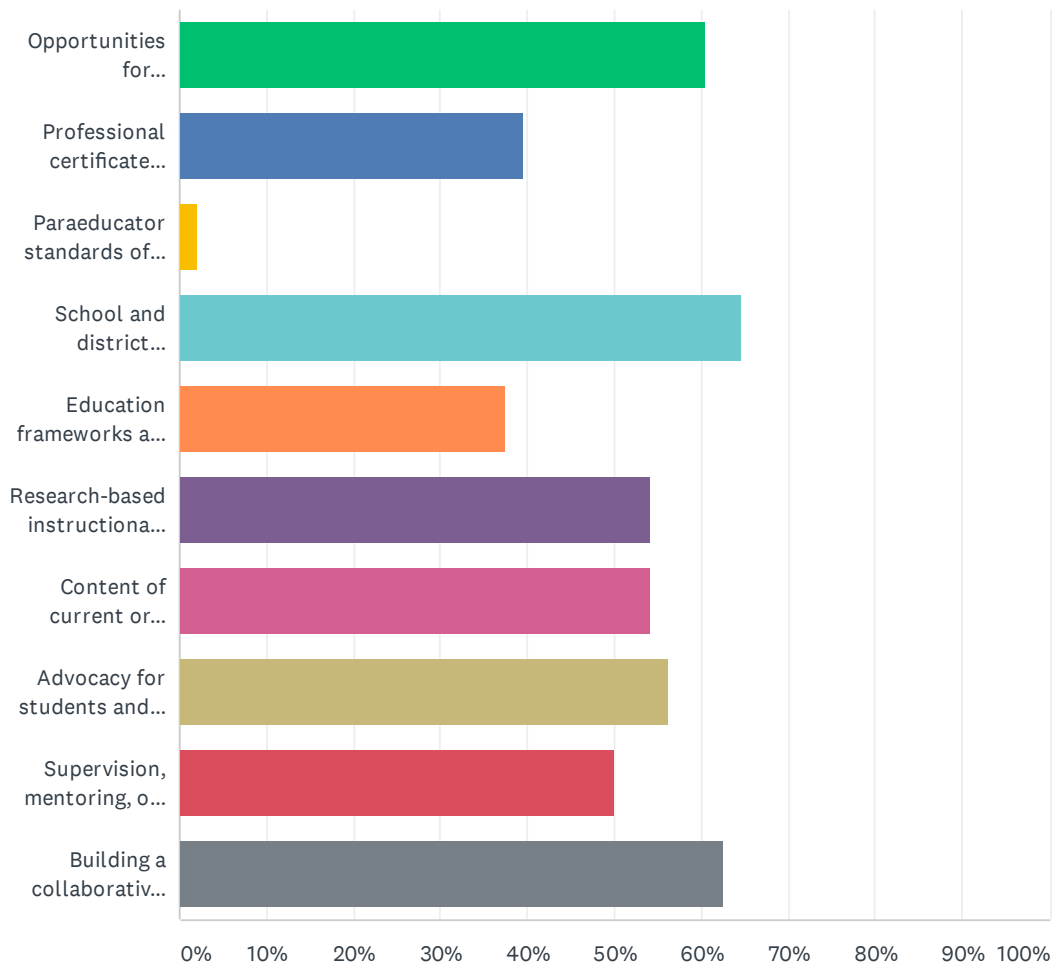

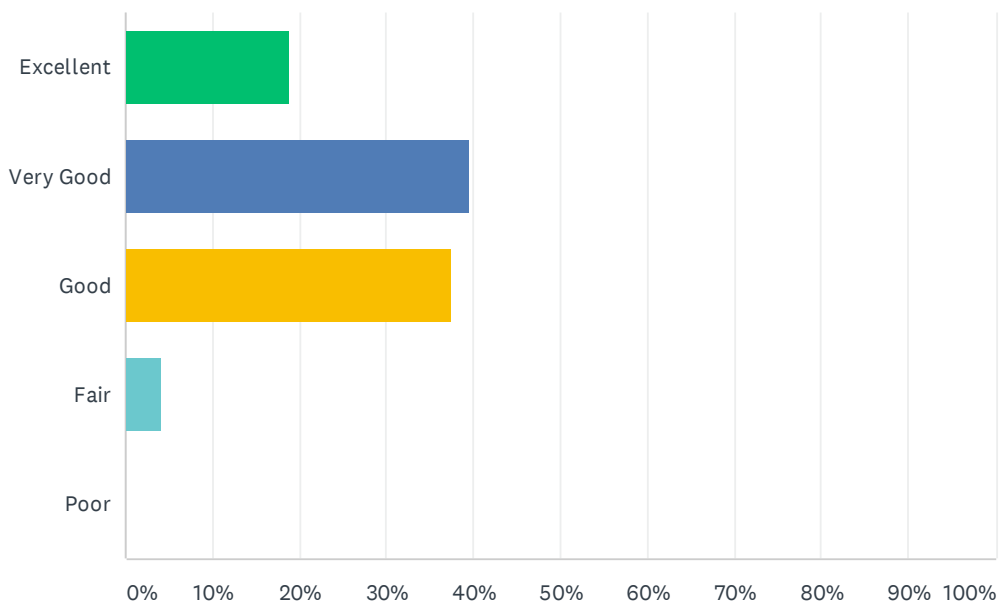
