- 3% annual inflation increase for executive assistants
- Transition vacation buy-out \$9,863
- Tim not asking for vacation buy-out never tracked vacation time
- Michelle starts July 1
- Tim to stay July and August
- Overlap of former Executive Director \$20,200
- Cash reserve fund to balance budget
- Mark How much in reserve? \$290,000
- Barbara Scully questioning cash reserve and Jesse salary
