Mastery-Based Learning Taskforce –Assistant Superintendent Kathe Taylor sits on this taskforce on behalf of OSPI. The taskforce has had three meetings since its inception. Please see the <u>December 2019 Interim Report</u> for more information.

#### **Staffing Updates:**

• Skilled and Technical Sciences Program Supervisor – posting closing January 31.

#### Course Approval System:

Courses that have an approval date before January 31, 2018 are considered **out of compliance** and therefore should **not be used to collect CTE enhanced funding**. Beginning January 31, 2018, districts should have submitted all active programs for approval. Any courses not captured in that Program Approval cycle would have required individual course applications and would still have an approval date after January 31, 2018.

Reminder to update Health science frameworks to the May 2019 Health Science National standards.

#### Legislative Update:

#### 1599:

State Board of Education (SBE) has rule-writing authority within this section, and adopted rules in final form on November 7, 2019. For the purposes of the CTE Graduation Pathway, the course sequence must meet minimum criteria and must include a minimum of 2 high school credits and be within the same program area or can be comprised of courses from different program areas, if approved by the school board, designee (Superintendent), or local advisory committee and approved by OSPI. The Expedited CTE Pathway Approval Form and instructions can be found on the OSPI website: <a href="https://www.k12.wa.us/student-success/career-technical-education-cte">https://www.k12.wa.us/student-success/career-technical-education-cte</a>. The CTE Graduation Pathway must include a minimum of 2 high school credit course sequence that includes access to dual credit or must include opportunity for the student to earn an industry certificate or be a course that leads to industry certification.

#### CTE Pathway Updates:

- <u>CTE Program of Study Template</u> Although basic design has been completed, there are additional recommended revisions to the template, in addition to needing to meet ADA compliance. We anticipate the final template being available than the end of January. It is currently with our Communications department for final approval.
- <u>State-Adopted Annual Industry-Recognized Certification List</u> –OSPI is deeply committed to a transparent process as well as an industry-driven product. We are still in process of completing the cross-walk of the District IRC Survey with current labor-market data, in addition to initial criteria (identified at fall conferences). Those that completed the initial survey will receive an individual email shortly—with an opportunity to confirm or change previous submissions. A PRELIMINARY list will be available at the end of January. Face-to-face focus groups (as well as electronic surveys) with industry to validate the certifications will be done through spring; the final ANNUAL list will be available towards the end of the school year (likely early May).
  - Note: Emails to districts that completed the initial survey begin receiving individual emails with an opportunity to confirm or change previous submissions yesterday.
